#### PUBLIC PRESENTATIONS

#### Cedar Point Subdivision – Undeveloped Lot on Morgan Lane

Stuart Miller had communicated with Vincent J. Rossi, Jr., Attorney for Town, expressing his concern with the proposed sale of an unimproved lot [owned by the Charles T. Sitrin Home] at 18 Morgan Lane, adjacent to his property. This particular lot has an unusual shape, with access via a narrow (single driveway width) strip of land that angles into a corner of the lot. His concerns include:

- Configuration of the lot
- "claimed" frontage of this property
- only potential driveway to the 18 Morgan Lane lot would overlap an existing driveway of the residence at 20 Morgan Lane.

Mr. Miller asked that the Town review the approved plans for this Development and determine the lot's compliance with zoning regulations. He also requested to be notified whenever someone applies for a building permit for this particular lot. The Town Board explained that a building permit application and map need to be submitted to the Codes Enforcement Officer before any determination can be made; and if it's a build-able lot, there's nothing the Town can do. However, if it doesn't meet Town code, Mr. Miller has the right to appeal to the Zoning Board of Appeals.

# Agreement for Engineering Services/Change Order #1 – Pump Station Upgrades

**NOW, THEREFORE, BE IT RESOLVED** that the New Hartford Town Board does hereby approve Change Order No. 1 to the contract with Shumaker Engineering in a not-to-exceed amount of Forty-eight Hundred Dollars (\$4800) for which Shumaker Engineering will provide design to select a diesel-powered mobile generator, change order negotiation and construction phase service, as set forth in their September 29, 2005 Budget Amendment to the Highway Superintendent; and be

Highway Superintendent Cleveland reported that, due to a series of recent events, his department has lost or will lose five (5) employees due to medical reasons; as a result of these temporary vacancies, there is a need for supplemental assistance in light of the approaching leaf collection season. Scott Brady's employment application has been reviewed by the Town's Personnel Assistant and has been approved by the Oneida County Department of Personnel. The Town Board briefly discussed authorizing the Highway Superintendent to hire two (2) temporary employees, the second employee (yet to be determined) to be contingent upon Town and County approval; the matter was deferred until the Town Attorney's arrival at this meeting.

## <u>Creation of Steering Committee – Comprehensive Master Plan</u>

- Conduct initial meeting with consultant to familiarize the Committee with the requirements of the program; attend up to five (5) additional regular meetings with Consultant as the Comprehensive Plan Update is prepared
- Input regarding the determination of potentials, issues, strengths, weaknesses and the "ideal" future of the Town
- Outline a detailed work program and schedule for the project and identify special interest groups that should be involved in the planning process.

## <u>Superseding Bond Resolution – Purchase of Highway Equipment</u>

The following Resolution was offered by Councilman Waszkiewicz, who moved its adoption; seconded by Councilman Butler, to-wit:

#### (RESOLUTION NO. 298 OF 2005)

A RESOLUTION AUTHORIZING THE PURCHASE OF HIGHWAY PLOWS IN AND FOR THE TOWN OF NEW HARTFORD, ONEIDA COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$243,174, AND AUTHORIZING THE ISSUANCE OF \$243,174 SERIAL BONDS OF SAID TOWN TO PAY THE COST THEREOF, AND SUPERSEDING A CERTAIN BOND RESOLUTION DULY ADOPTED BY THE TOWN BOARD OF SAID TOWN ON JUNE 15, 2005 FOR THE AFORESAID PURPOSES.

**BE IT RESOLVED** by the affirmative vote of **not less than two-thirds of the total voting strength** of the Town Board of the Town of New Hartford, Oneida County, New York, as follow:

<u>Section 1.</u> The purchase of highway plows in and for the Town of New Hartford, Oneida County, New York, including apparatus, is hereby authorized at a maximum estimated cost of \$243,174.

<u>Section 2.</u> The plan for the financing of such maximum estimated cost is by the issuance of \$243,174 serial bonds of said Town hereby authorized to be issued therefore pursuant to the Local Finance Law.

<u>Section 3.</u> It is hereby determined that the period of probable usefulness of the aforesaid class of objects or purposes is fifteen years, pursuant to subdivision 28 of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized **will not exceed five years.** 

<u>Section 4.</u> The faith and credit of said Town of New Hartford, Oneida County, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall be levied on all the taxable real property in said Town, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

<u>Section 5.</u> Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Supervisor of said Town, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor, consistent with the provisions of the Local Finance Law.

<u>Section 6.</u> All other matters except as provided herein relating to the serial bonds herein authorized including the date denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability of issue bonds with substantially level or declining annual debt service, shall be determined by the Supervisor, the chief fiscal officer of such Town. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Supervisor shall determine consistent with the provisions of the Local Finance Law.

<u>Section 7.</u> The validity of such bonds and bond anticipation notes may be contested only if

- 1) Such obligations are authorized for an object or purpose for which said Town is not authorized to expend money, or
- 2) The provisions of law which should be complied with at the date of publication of this Resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

3) Such obligations are authorized in violation of the provisions of the Constitution.

<u>Section 8.</u> This Resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this Resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

Section 9. It is hereby determined that this Bond Resolution shall supersede the Bond Resolution duly adopted by the Town Board of said Town on June 15, 2005, authorizing the issuance of \$220,468 serial bonds of said Town substantially for the purposes authorized herein.

<u>Section 10.</u> This Resolution, which takes effect immediately, shall be published in summary form in *The Observer Dispatch*, which is hereby designated as the official newspaper of said Town for such purpose, together with a notice of the Town Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

The question of the adoption of the foregoing Resolution was duly put to a vote on roll call, which resulted as follows:

- <u>Supervisor</u> enter into a written lease for the purpose of renting, maintaining, accessing and terminating a Safe Deposit Box at Adirondack Bank.
