#### PUBLIC HEARING

# Eminent Domain - Beechwood Road Drainage Improvement, Phase 2

The Town Supervisor announced that a Public Hearing was to have been held this evening on the acquisition of property pursuant to Article 2 of the Eminent Domain procedure Law; however, the Town Attorney explained that the Eminent Domain Procedure requires that the public notice be published five (5) successive days in the Observer Dispatch and at least ten (10) days but not more than 30 days prior to the Public Hearing date. In reviewing procedures, it was discovered that the Town didn't have sufficient time to meet the publication requirements. In the interim, the Town had a meeting with Ken Knutsen of Barton & Loguidice and property owners of potential easements were invited to a meeting on April 2, 2013 and a number of property owners did attend the meeting, which the Town Attorney thought was good and that Mr. Knutsen did a wonderful job explaining what the Town hoped to do....good discussion....another meeting is to be scheduled for the middle of next week. Mr. Knutsen will walk the property with one owner who has some concerns....looks optimistic that the Town might not have to pursue the eminent domain process. In response to the Town Supervisor's inquiry about scheduling the Public Hearing for the April 24, 2013 Town Board meeting, the Town Clerk stated the Town does not have enough time to meet the more stringent publication requirements and that the Observer Dispatch needs the article for publication three (3) days in advance of the requested publication date. The May 8, 2013 Town Board meeting would be the first that the Hearing could be held. Thereafter, Councilman Reynolds introduced the following Resolution, moving its adoption; seconded by Councilman Miscione:

#### (RESOLUTION NO. 75 OF 2013)

**RESOLVED** that, pursuant to Article 2 of the Eminent Domain Procedure Law, the Town Board of the Town of New Hartford does hereby schedule a Public Hearing to commence at 7:00 P.M., or as soon thereafter as reached in the regular course of business, on Wednesday, May 8, 2013 in Butler Memorial Hall, New Hartford, NY, for the purpose of describing the proposed construction of stormwater improvements and the acquisition of a permanent easement approximately across the property located at and known as 28 Wills Drive, New Hartford, NY (portion of Tax Map No. 339.011-1-92) and an additional temporary easement for the purpose of construction of stormwater improvements; and be it

# Windmills/Turbines

Mark Krasinski was interested in wind turbines but noticed that matter was not on tonight's agenda and he understands from past meetings that the Town is working on legislation. He stated that Jonathan Knauth would be making a presentation on wind turbines and he had given copies of the meeting notice to Councilman Reynolds. Mr. Krasinski asked that the Town Board review Mr. Knauth's report, "Decommissioning estimate – Vestas V3.0-112 Turbines on the proposed Monticello Hills Project"; the Town Clerk will email copies to the Town Board and Town Attorney.

#### <u>Consumer Square/Benderson – Traffic Light</u>

Edmund Wiatr, Jr. stated that he and Catherine Lawrence had attended the April 8, 2013 Town Planning Board meeting and at which time a Planning Board member had concern over the timely receipt of information with relation to the Benderson application for something they were doing at Consumer Square; further, that the application indicated Benderson was paying for a new traffic light. It had come to Mr. Wiatr's attention that the Town Attorney had been served with a Notice of Claim and legal papers by Benderson (aka Trahwen) and it appeared that no one on the Planning Board knew about this litigation against the Town. Mr. Wiatr stated that Planning Board member Mowat spoke up during that meeting, stating that the Town is paying for the traffic signal through mitigation fees. Mr. Wiatr thinks the Planning Board not knowing anything about the litigation could have affected their vote and that Ms. Mowat was the sole "no" vote.

Town Supervisor Tyksinski clarified that there are two (2) new lights being installed at the Consumer Square site; one (1) within the shopping plaza, for which Benderson is

paying, and which the NYS Department of Transportation had wanted for years. The second light is being installed on Commercial Drive near Panera's and that light is being paid by the Town through mitigation fees; "...it's the Town's obligation", he said. Addressing Mr. Wiatr's question about the status of the lawsuit, the Town Attorney noted that because there is pending litigation, the matter could not be discussed in open session; he did state, however, that there have been a number of motor vehicle accidents at the Commercial Drive-Panera exit of Consumer Square and that the NYS Department of Transportation wants a traffic signal there.

# <u>Update of 2007 Comprehensive Plan & new Zoning Law – River Street Planning & Development</u>

The Town Supervisor had met with representative(s) of River Street Planning & Development with regard to progress on the Town's 2007 Comprehensive Plan. River Street did make some concessions and the Town has an amended fee schedule and timeline for expected completion dates, copies of the latter of which will be given to Town Board members. The Town Attorney acknowledged that Codes Enforcement Officer Joseph Booth "..has done an awful lot of work on this...and a lot of questions answered on the Southern GEIS.." with the help of clerical staff.; as a result, River Street will complete their work in a faster time and reduce the cost by a considerable amount of money. Thereafter, Councilman Miscione offered the following Resolution for adoption; seconded by Councilman Woodland:

#### (RESOLUTION NO. 81 OF 2013)

WHEREAS, the Town of New Hartford and River Street Planning & Development had entered into an Agreement dated January 21, 2013 for River Street Planning to update the Town of New Hartford Comprehensive Plan and prepare a new Zoning Law; and

**WHEREAS,** said Town has since requested that River Street Planning expedite the schedule for completion of the Comprehensive Plan and Zoning Law, to which River Street Planning has agreed;

**NOW, THEREFORE, BE IT RESOLVED** that the New Hartford Town Board does hereby accept and approve the revised Agreement (Amendment No. 1) between the Town and River Street Planning regarding the modification of scope of work to update the Comprehensive Plan and prepare a new Zoning law; said revised Agreement reduces the total contracted price between the Town and River Street Planning from the initial not-to-exceed \$71,435.00 to a new total contracted amount not-to-exceed \$57,875.00. The Town Supervisor is hereby authorized and directed to enter into and to execute said revised Agreement (Amendment No. 1).
