Willowvale Fire Company - fire horn

Judy Cusworth of Chadwicks presented her complaint about the Willowvale Fire Department; specifically, that the fire horn blows 33 times when a call is received at the Fire department and that the noise actually vibrates the windows in her home; and questions whether the noise would devalue the worth of her home. Both she and her fiancée have, on separate occasions, discussed this matter with Fire Chief Kuhn to no avail. That's when she contacted Councilman Messa who witnessed the blowing horn, as well as Code Enforcement Officer Joseph Booth who visited her property. Councilman Messa spoke with Willowvale Fire officials on several occasions that they should contact the company who installed the fire horn but nothing has been done. Ms. Cusworth stated there are times that the horn blows 66 times and most recently at the fire at the corner of Oxford and Tibbitts Roads, the horn blew 99 times. She submitted to the Board a letter from Kevin Revere of the 9-1-1 Center. Ms. Cusworth believes the horn blowing is overkill since the firefighters have scanners, radios in their vehicles and fire radios that they carry on themselves. The Town Supervisor requested that Councilman Messa contact the Willowvale Fire Company officials one more time to resolve this matter. Ms. Cusworth had received word that the Fire Company can actually turn off the horn themselves inside the firehouse.

Nuisance Abatement Update – 42 Slusser Avenue

The Town Attorney reported that Code Enforcement Officer Joseph Booth has been in contact with the owner/absentee landlord of 42 Slusser Avenue, who has promised to fix things but doesn't. Therefore, the Town has commenced court action and the Town Attorney will prosecute the case.

Town Attorney Herbert J. Cully:

Sherrill Lane – proposed land sale

After the August 2015 Town Board meeting, the Town Attorney sent a Memo to the Town Board members notifying them that some of the abutting property owners – after learning that the filing fees at the County could be in excess of \$300 each – aren't interested in pursuing this. The matter is on hold; it's not going forward now.

Tax Certiorari proceeding - Kohl's

The Kohl's tax certiorari proceeding has been discontinued and the Town Attorney has received the Stipulation of discontinuing their action.

<u>Local Law Introductory "F" of 2015; Lead Agency; Town and County Planning referral; SEQR; Public Hearing scheduled</u>

The Town Attorney noted that there has been some confusion over the definition of "building area" and, toward that end, he suggested that the Town Board amend the Zoning Law text to include the definition of "building area" as it appears in the New York State Building Code. This has been a debate between the developers and the Town as to what constitutes a "building area". After some discussion, Councilman Miscione introduced the following legislation for adoption at a future Public Hearing; seconded by Councilman Woodland:

Town of New Hartford, New York Local Law Introductory "F" of 2015

A Local Law to amend the Code of the Town of New Hartford, Chapter 118 thereof entitled ZONING, Section 118-14. Definition., by adding the definition of "building area".

BE IT ENACTED by the Town Board of the Town of New Hartford as follows:

Section 1. Chapter 118 (Zoning) of the Code of the Town of New Hartford, Section 118-14. Definition. is hereby amended to include the following definition:

AREA, BUILDING. All areas contained within exterior walls exclusive of open courts is the building area or total square footage. The definition actually includes any area under the roof even if they are open, so the portico of a hotel or a covered porch is included in REGULAR TOWN BOARD MEETING September 9, 2015 Page 10 of 14

building area. The impacts associated with the size of a development are cumulative and while multi-story buildings do not increase the amount of storm water runoff, the total size of the structure has obvious impacts on highway, domestic water, and police usage.

Section 2. All other provisions of Chapter 118 of the Code of the Town of New Hartford, and amendments thereto, are hereby affirmed except to the extent that this Local Law shall modify or amend.

Section 3. This Local Law shall become effective immediately upon its filing in the Office of the Secretary of State.

Councilman Miscione then introduced the following Resolution for adoption; seconded by Councilman Woodland:

Notice of Claim – Robert Kessler

Sherrill Lane – proposed land sale

Councilman Messa stated that the neighbor who had initiated the conversation about purchasing some of Town-owned land behind his residence, has asked if the Town Board would consider selling him that portion behind his residence since he's on the end and then property owner 2, 3, 4 etc. could purchase a portion. The Town Attorney will check to see how to handle this; Councilman Messa will have the property owner contact Attorney Cully.

FOIL Appeal - Sherrill Lane land sale proposal

With regard to the FOIL appeal filed by Cathy Lawrence, Ms. Lawrence confirmed she now has received a copy of the Donato appraisal of the Town-owned land behind Sherrill Lane but has not received a copy of the invoice; the Town Attorney believes the invoice for \$200 should be forthcoming. Ms. Lawrence expressed concern that she might not have received all the documents she had requested. Attorney Cully said he had a couple telephone calls. As long as everybody certifies they have no further documents, she is satisfied her FOIL request has been met.
