PUBLIC HEARING

7:01 P.M. Local Law Introductory "F" of 2015

Zoning Law text amendment Definition of "building area"

At 7:01 P.M. the Town Supervisor opened the Public Hearing on Local Law Introductory "F" of 2015, which if adopted, would amend the Town's Zoning Law, Section 118-14, to include the definition of "building area". The legislation was proposed to clarify "building area" as it relates to the Town's mitigation fees.

[NOTE: The Town Clerk had available the legislation, Affidavit of Posting and Proof of Publication (September 23 2015, edition of The Observer Dispatch). Also available were the SEQR responses from the New Hartford Fire Department, New Hartford Police Department and the Oneida County Department of Public Works and the recommended approvals by the Town Planning Board and Oneida County Planning Department.]

The Town Attorney explained there had been some confusion and issues raised by developers as to the computation of mitigation fees; the mitigation fees are computed – or at least part of them – are computed by "building area" of the structure being constructed. The confusion lies as to whether the "building area" just includes the ground floor or the multi-level floors if, in fact, the structure is two (2) or three (3) floors. To clear this up, with the help of Code Enforcement Officer Joseph Booth, the accepted definition of "building area" was confirmed and it is proposed to include this definition in the Town's Zoning Law.

The Town Supervisor inquired if anyone present wished to speak in favor of or in opposition to Local Law Introductory "F" of 2015. There being no one who came forth to speak, the Public Hearing was closed at 7:02 P.M.

Adoption of Local Law Introductory "F" of 2015 as Local Law No. Seven of 2015

No one having come forth and the Town Board members having no comments, Councilman Reynolds moved that Local Law Introductory "F" of 2015 be adopted as Local Law No. Seven of 2015, in the following format; seconded by Councilman Miscione:

Town of New Hartford, New York Local Law No. Seven of 2015

A Local Law to amend the Code of the Town of New Hartford, Chapter 118 thereof entitled ZONING, Section 118-14. Definition., by adding the definition of "building area".

BE IT ENACTED by the Town Board of the Town of New Hartford as follows:

Section 1. Chapter 118 (Zoning) of the Code of the Town of New Hartford, Section 118-14. Definition. is hereby amended to include the following definition:

AREA, BUILDING. All areas contained within exterior walls exclusive of open courts is the building area or total square footage. The definition actually includes any area under the roof even if they are open, so the portico of a hotel or a covered porch is included in building area. The impacts associated with the size of a development are cumulative and while multi-story buildings do not increase the amount of storm water runoff, the total size of the structure has obvious impacts on highway, domestic water, and police usage.

Section 2. All other provisions of Chapter 118 of the Code of the Town of New Hartford, and amendments thereto, are hereby affirmed except to the extent that this Local Law shall modify or amend.

Section 3. This Local Law shall become effective immediately upon its filing in the Office of the Secretary of State.

PUBLIC PRESENTATIONS/COMMENTS

Excessive speed – texting on Oxford Road (Village)

Nancy Slade expressed concerns of her observations while on her daily walk along Oxford Road beginning at 8:00 A.M.; specifically people driving vehicles at excessive

speeds and using their cellphones. Around 10:30 A.M. she's witnessed student drivers leaving the school for lunch with cellphones in their hands and kids in the back seat. Adults have been seen doing the same thing. With regard to the Police Department speed trailer sometimes set up at the Oxford Road School, Chief Inserra noted that the trailers are not designed for the issuance of tickets, but to warn motorists of the speed at which they are driving. Ms. Slade believes the Police Department needs a second speed trailer and offered to assist with fundraisers to purchase another trailer. The Town Supervisor and Chief Inserra will discuss her concerns and get back to her.

The Tentative Budget proposes a zero percent (0%) tax increase for 2016. It includes raises for union and non-union employees, no equipment. Supervisor Tyksinski asked the Councilmen to review the Tentative Budget and to contact him with any concerns or questions. He stated that the Town Board will hold a Special Board meeting on Monday, October 19, 2015, at 5:30 P.M. in the Supervisor's Office, Butler Memorial Hall, due to a conflict with the Zoning Board of Appeals meeting at the same time in the Community Meeting Room of Butler Memorial Hall. The Town Supervisor said that the purpose of the Special Meeting will be to adopt a Preliminary Budget for 2016 and schedule a public hearing to be held not later than the Thursday following Election Day.

Bid Process - Demolition of Unsafe Building at 44 Beechwood Road

Councilman Messa brought up the matter of the proposed demolition of 44 Beechwood Road; a Hearing had been conducted immediately prior to the August 2015 Town Board meeting. The Town Supervisor asked Councilman Messa to work with Highway Superintendent Richard Sherman and Attorney Cully to prepare specifications for the demolition and begin the bid process and that the specifications be brought to the next Town Board meeting. Attorney Cully reported that Judge Siegel had confirmed the Town's Order for demolition of 44 Beechwood Road.

Unsafe Building - Code, Chapter 52, Primary Lien Holder

Councilman Messa inquired whether the Town Code, Chapter 52 (Unsafe Buildings) could be amended so that, in the event of a structure fire and the Town knows the property owner's name, that the Town should be the first in line as the primary lien holder before the insurance company settles the matter; current legislation does not have this provision. Code Enforcement Officer Joseph Booth confirmed that current legislation allows the Town to place demolition costs as a lien against the real property.

The Town Attorney will work on this and present the proposal at a future Board meeting.

Unsafe Building 9458-9460 Elm Street, Chadwicks - Town Code, Chapter 524.

Councilman Messa has talked with a couple of neighbors adjacent to the residential duplex at 9458-9460 Elm Street, Chadwicks, regarding the condition of this <u>vacant</u> property which is in foreclosure; he has visited the property and reported there definitely is some mold present as well as carpenter bees and carpenter ants. Supervisor Tyksinski believed the Town had looked at this situation previously and Code Enforcement Officer Joseph Booth confirmed that while this property has been on the radar since April 2015, he has never been inside the house. The bank has hired SafeGuard to mow the lawn and remove debris; the Town has secured the structure(s).

William Petrilli, accompanied by his wife and daughter, who own three (3) parcels adjacent to the subject duplex, alleged that the house is not structurally sound and is infested not only with rats, woodchucks, and carpenter ants and bees, but also mold, the latter of which he can smell when the wind blows a certain way. He submitted photos of the property dated September 28 and September 29, 2015. He has witnessed the SafeGuard employees enter the house wearing hazmat suits and was told by them that hazardous materials are in the structure and a 55-gallon drum. Mr. Petrilli feels the Town is prolonging a dangerous situation and that the property is "..an accident waiting to happen". He went inside the house during the Summer with a SafeGuard employee and said "..the place is a mess". Currently, the shed is wide open again and the two (2) basement doors are open; "..kids go in there".

The Code Enforcement Officer said he doesn't see a structural issue. He did provide the Town Attorney with the telephone number of the bank's attorney handling the matter and the Town Attorney said he has a call into that attorney. He will follow up to determine the status of foreclosure. The Town Supervisor wasn't sure that the Town had enough documentation of mold, hazardous materials, etc. The Town Attorney stated that, from a legal standpoint, the Town would have to be on firm ground to order the demolition of someone's house; he would want to see the Code Enforcement Officer's opinion because it would be that person who brings the matter before the Town Board, but the Code Enforcement Officer hasn't had the opportunity to gain access if, in fact, the bank has taken over.

Addressing Mr. Petrilli, Councilman Reynolds stated that the Town Board is in the process of demolishing two (2) houses that are in very bad shape so this Board is sympathetic – it's a process.

<u>Property Maintenance – 42 Slusser Ave</u>

In response to Councilman Reynolds' inquiry, Code Enforcement Officer Joseph Booth
