Thereafter, the Supervisor declared a quorum present for the transaction of business.

**PUBLIC COMMENTS:**

**BMX FOUNDATION – PARKS PRESENTATION:**

Nicholas Rauch, Current Track Director, CNY BMX and Bill, Kelly & Brady Colbert presented the Town Board with a proposal to request space in the New Hartford Town Park as they are looking to relocate the bicycle motocross track.

Mr. Rauch told the Board there organization is 100% volunteer and self-sustaining and they have been in existence since 2001. The program generally runs from April to October. Their target population includes children as young as 2 and adults as old as 63 and it is a mix of boys & girls. They currently have 40 racers on a typical night and are looking to grow the program. They are requesting a 1200 foot track made of a mix of dirt & asphalt with a 6 foot fence around the facility. The track will have lights, speakers with a PA system, and security fence. They will need the use of a building and parking and also will provide full insurance.

Town Attorney Cully will look into what other municipalities have done & he will also look into the NYS Parks.

Councilman Reynolds would like to see the footprint set up and get an idea of what the lighting will look like and was concerned with what the Towns portion of this would be as the Highway Department is already very busy.

Supervisor Miscione will view the requested site with the Board Members and said this is very exciting for young kids and an asset to the Town Park. He said he already has a site picked out and the track will help to beautify the park and clean up some dead trees. He also said it would be less maintenance for the Town.

This matter was tabled for further discussion.

**PUBLIC COMMENTS:**

Mike Scalzo – 9429 Mallory Road – He spoke to the Town Board regarding the creek that runs from the top of the hill to the bottom and how he and his neighbors are losing land, bridges, property, sheds, and trees. He presented the Town Board with pictures and videos. He said the property up there is washing away and it is getting significantly worse. He told the board about the cost to repair the property and damaged land. The residents up there are dealing with washed down trees logs, boulders and spending their own money to repair the damage. He said years ago it was a small stream but now it's powerful and dangerous. He also told the Town Board he also is concerned with a 4 to 5 foot drop up there as it poses a hazard for children and the previous owner of his house died mowing his lawn after it tipped over. The residents are requesting large culvert pipes and to have them all filled in and a study of that area to show why this is happening and what can be done.

Highway Superintendent Sherman told the Town Board that Dunn & Segrmo are of aware of those issues in that area.

Town Supervisor Miscione said he will forward everything presented tonight to the Engineers Dunn & Sgermo and they will see what they can come up with.

**DISCUSSION:**

Councilman Lenart knows it is needed but inquired where the Town stands with the budget and he is not comfortable with replacing the roof at this time.

Councilman Messa asked if this included the drive through.

Supervisor Miscione replied they have the money to do a cardboard roof and it can be done in house to stop some leaks.

Councilman Messa stated he is concerned with the amount of money the Board was putting into the Recreation Center and that the Board continues to spend even though and then he said he just wants to be cautious.

Supervisor Miscione said he cut spending in the Annual Budget and the Town is already working on bear mandated employees.

Councilman Reynolds wanted to be sure the Town is still on track with the stormwater projects.

Superintendent Sherman said yes and he trimmed his budget a bit with the Stripping Agreement with Oneida County. He said because the County came in so high he decided to hire a private Contractor to do the Towns Stripping this year. He will use the same materials and the work will be done in 1 week with 40 hours of work. He said this was a huge saving to the Town.

Supervisor Miscione said he can find some savings with the Lawn Cutting Contract.
